SPECIFICATIONS / TERMS OF REFERENCE / STATEMENT OF WORK

Introduction

Taimako Community Development Initiative is supporting the population with critical water, sanitation and hygiene. Communities will be reached with access to safe and sufficient water through rehabilitation of existing nonfunctioning water boreholes and construction of new Solar Powered boreholes, construction of sanitation facilities, and other hygiene promotion activities.

The project Contract Packages are as follows;

- 1. Construction of Solar Powered borehole in Bulyunwa Community, Fune LGA, Yobe State.
- 2. Rehabilitation of Solar Powered borehole in Kachalla Bauya Community, Potiskum LGA, Yobe State.

TCDI is currently in the process of **prequalifying contracting firms** with substantial presence and extensive experience within Northeast Nigeria, for the supply of packages based on the major components mentioned above. The contracting firms will be working under the direction of the TCDI field team and supervised by a technical team consisting of senior members from any of these agencies; WASH Cluster, RUWASA, LGA WASH UNIT, MoWR, and WASHCOM trained by TCDI.

Qualifications:

- Reputable corporate international/national organizations with 5 years of experience in some or all of the above activities.
- Proven track record with strong engineering (technical) and management team; (documentary of proof to be provided);
- Joint venture¹ partnership with reputed international/national organizations with expertise in the construction of Water facilities.

¹ ¹ For the joint venture, the association between Local and Foreign construction Firms is strongly encouraged particularly with respect to expertise in water desalination plant design and construction. Construction Firms may only associate with each other in the form of a joint venture or in a sub-contracting agreement to complement their respective areas of expertise to enhance their capacity to successfully carry out the assignment.

- Good track record on the supply, delivery, and construction of the above contract packages;
- Good track record and experience in construction and contract management;
- Strong interpersonal and communication skills for reporting and negotiating with relevant authorities;
- The institutional contractors must provide TCDI with: A certificate of Incorporation/ documentation as a registered company or institution; evidence of similar works and undertakings, evidence of the availability of qualified personnel, and evidence of ability to mobilize qualified personnel.
- Ability to mobilize international expertise to Nigeria
